

Je représente la société pharmaceutique géorgienne « Aversi – Rational ». Il est le plus grand fabricant de niveau mondial des médicaments non seulement en Géorgie, mais dans toute la Transcaucasie. Il fabrique les produits de haute qualité, efficaces, fiables et sûrs au marché pharmaceutique ; Il crée les emplois et élargie sa production. Les analyses comme psycho-chimiques, ainsi que microbiologiques sont effectuées au laboratoire moderne d’Aversi – Rational. Il occupe le territoire de 750 mètres carrés de l’usine. Au mois de janvier 2014 l’accréditation conforme au standard ISO/IEC 17025 qu’il a passé atteste le fait de la bonne fonctionnalité technique du laboratoire ; Le laboratoire d’Aversi – Rational est conforme aux exigences des standards des principaux fabricants pharmacologiques du monde. Le nouveau laboratoire, ainsi que toute l’usine ne sont équipés que par les installations et inventaires les plus avancées de l’Europe, des Etats-Unis et du Japon ce qui représentent à son tour la garantie de la fiabilité de toutes les analyses effectuées ;

L’achat des matières premières s’effectue seulement auprès des sociétés pharmacologiques connues dans le monde ; la qualité et la sécurité des matières premières sont ensuite contrôlées dans le laboratoire ; Toutes les installations utilisées au cours du processus de la fabrication sont

agrées à l'échelle du monde par les meilleurs fabricants de l'Europe, des Etats-Unis et du Japon. Les procédures du contrôle de la conformité des machineries-installations sont régulièrement réalisées, les preuves documentées y liées sont établies pour confirmer le fonctionnement efficace et stable des installations ; Le personnel d'Aversi - Rational assiste régulièrement aux différents trainings concernant au travail avec les machineries-installations modernes comme en Géorgie, ainsi qu'à l'étranger, surtout au sein des complexes industriels des fabricants ; La demande des produits d'Aversi - Rational est considérablement augmentée non seulement en Géorgie, mais aux marchés étrangers ce qui confirme à son tour le fait que ces produits sont fiables et de haute qualité.

Les marchés africains sont très attirants et perspectifs pour nous ; Nous sommes heureux d'avoir la chance de la coopération avec vous. 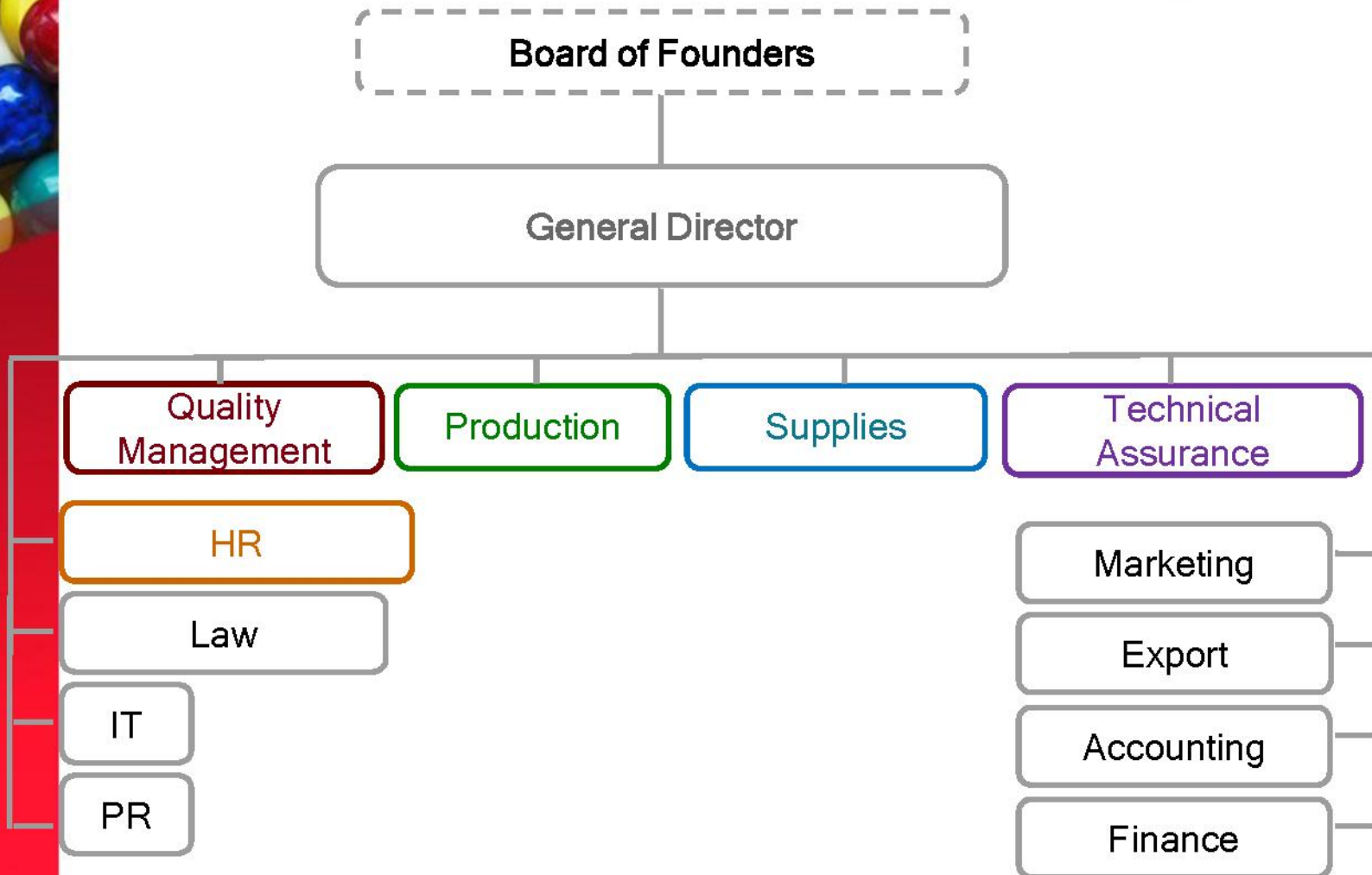
